- 5. Floats must have walkers if the vehicle is wider than 8 feet and/or longer than 20 feet.
- 6. Entries must be in formation no later than 6:30 pm (Line-up will be from the Museum on Necanicum drive, facing south)
- 7. Entries will be judged in front of the Carousel Mall.
